INVITATION TO BID FOR Supply and Delivery of Various IT Supplies and Equipment (Early Procurement 2021)

- 1. The <u>Camarines Norte State College</u>, through the <u>2021 General Fund</u> intends to apply the sum of <u>One Million Two Hundred Ninety Five Thousand Five Hundred Fifty Nine & 78/100 (P1,295,559.78) Pesos.</u> being the ABC to payments under the contract for <u>Supply and Delivery of Various IT Supplies and Equipment (Early Procurement 2021)</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The <u>Camarines Norte State College</u> now invites bids for the above Procurement Project. Bidders should have completed, within <u>three (3) years</u> from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the <u>HEAD, BAC SECRETARIAT FOR GOODS AND SERVICES, CAMARINES NORTE STATE COLLEGE</u> and inspect the Bidding Documents at the address given below during <u>office hours, Monday to Friday.</u>
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>December 2, 2020 to December 22, 2020 in payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the <u>amount of Five Thousand Pesos (Php 5,000.00)</u>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.</u>
- 6. The <u>Camarines Norte State College</u> will hold a Pre-Bid Conference on <u>December 10</u>, <u>2020 at 9:00 in the morning at Main Campus Library</u>, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission or through courier at the office address indicated below on or before <u>December 22, 2020</u> at 9:00 in the morning. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

- 9. Bid opening shall be on *December 22, 2020 at 9:30 in the morning* at the given address to attend the activity.
- The <u>Camarines Norte State College</u> reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
