INVITATION TO BID FOR Subscription of Online E-Resources for the College Library

- The Camarines Norte State College, through the 2022 Income Fund intends to apply 1. the sum of Three Million Three Hundred Ninety Eight Thousand Seven Hundred Fourteen Pesos (P3,398,714.00) being the ABC to payments under the contract for Subscription of Online E-Resources for the College Library. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Camarines Norte State College now invites bids for the above Procurement 2. Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-3. discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Camarines Norte State 4. College and inspect the Bidding Documents at the address given below during office hours, Monday to Friday.
- A complete set of Bidding Documents may be acquired by interested Bidders on June 5. 14, 2022 to July 4, 2022 in payment of the applicable fee fro the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB in the amount of Five Thousand (P5,000.00) Pesos. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- The Camarines Norte State College will hold a Pre-Bid Conference on June 22, 2022 6. at 9:00 in the morning which shall be open to prospective bidders.

To reduce the risks and hazards of community transmission of COVID-19, the BACGS shall conduct pre-bid conferences via video conferencing until further notice, or until such time that the implementation of community quarantine or similar government restrictions shall have been lifted by the proper government authorities.
