- The <u>Camarines Norte State College</u>, through the <u>2022 Trust Receipt (DA) Fund</u> intends to apply the sum of <u>Four Million Three Hundred Thirty-Eight Thousand</u> <u>Pesos & 21/100 (P4,338,000.21)</u> being the ABC to payments under the contract for <u>Supply and Delivery of Various Supplies & Materials (live animals, feeds, medicines and office supplies) for the <u>Upgrading of Swine Multiplier Farm in Camarines Norte</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.</u>
- The <u>Camarines Norte State College</u> now invites bids for the above Procurement Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, <u>within three (3) years</u> from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on October 4- 2022 in payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 7. The <u>Camarines Norte State College</u> will hold a Pre-Bid Conference on <u>October 10</u>, 2022 at 9:00 in the morning (Zoom Link will be made available through Bid <u>Bulletin at Philgeps</u>) which shall be open to prospective bidders.

To reduce the risks and hazards of community transmission of COVID-19, the BACGS shall conduct pre-bid conferences via video conferencing until further notice, or until such time that the implementation of community quarantine or similar government restrictions shall have been lifted by the proper government authorities.

- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before October 24, 2022 at 9:00 in the morning. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on <u>October 24,2022 at 9:30 in the morning</u> at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The Camarines Norte State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
