CAMARINES NORTE STATE COLLEGE (CNSC), a government educational institution between: created by RA.A. 7352, with principal office at F. Pimentel Avenue, Daet, Camarines Norte, represented by its President, MARLO M. DE LA CRUZ, PhD, PECE, Head of the Procuring Entity. hereinafter referred to as "CNSC",

-AND-

JERICHO SECURITY & INVESTIGATION SERVICES, with principal business address at Ground Floor, Amaluz Building, Purok 7, Locsin Subdivision, Brgy. Binitayan, Daraga Albay, represented by its Proprietor/Owner, GERALDINE B. LASTRELLA, hereinafter referred to as "SECURITY AGENCY".

WITNESSETH:

WHEREAS, pursuant to BAC Resolution No. 38, s2022 dated September 13, 2022, CNSC declared the SECURITY AGENCY as the bidder with the Lowest Calculated and Responsive Bid for the SUPPLY OF SECURITY SERVICES FOR THE SIX (6) CAMPUSES OF THE COLLEGE in the amount of Seven Million Five Hundred Forty-One Thousand Seven Hundred Fifty-Nine Pesos and Twenty-Eight Centavos (PHP 7,541,759.28), hereinafter called the "Contract Price";

WHEREAS, the CNSC is engaging the services of the SECURITY AGENCY for the purpose of deploying licensed security guards to safeguard and protect its properties, equipment and facilities / installations / office buildings within its premises against any and all crimes / unlawful acts and any act of terrorism by strangers or third persons. The services herein engaged shall also cover the necessary security measures for all CNSC officers, employees, students and its visitors transacting legitimate business in the CNSC premises

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to:
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz
 - Philippine Bidding Documents (PBDs):

General and Special Conditions of Contract

- All the provisions of the TERMS OF REFERENCE in the Procurement of Security Services for the Camarines Norte State College not inconsistent with this Contract Agreement, except for the effectivity of the contract which is clearly defined hereunder,
- Supplemental or Bid Bulletins, if any
- Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Performance Security;
- Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- The SECURITY AGENCY covenants to provide CNSC with the necessary number of Security Guards as herein stated in complete uniforms and security gears, and in no case they shall be allowed to be posted without proper orientation on school polices, rules and regulations;
- Nothing contained herein shall be construed as establishing an Employer-Employee Relationship or of Principal and Agent as between CNSC and the SECURITY AGENCY. The latter, subject to the provisions of this contract, has complete charge of its personnel performing the security services and shall be fully responsible for the services performed by them on their behalf, thus, a qualified Security Supervisor shall be provided by the SECURITY AGENCY;

The Thirty-Six (36) Security Guards shall be deployed and posted in accordance with the schedule to determined by CNSC;

- In consideration of the security services performed and provided by the SECURITY AGENCY under this contract, CNSC undertakes to make payment on a monthly basis per actual work performed by their security guards;
- The SECURITY AGENCY covenants to observe working hours, overtime, work pay and other labor standards under the Labor Code;
- The SECURITY AGENCY hereby covenants to strictly implement CNSC's policies, rules and regulations;
- The SECURITY AGENCY agrees to deploy such number of Security Guards mentioned above and shall be changed with another batch of Security Guards every month, if warranted, except the Head Guard/Supervisor, if there's any:
- 10. The SECURITY AGENCY shall strictly implement the school policy with respect to CNSC personnel's "going-out" of the campus with or without Pass Slips during office hours from 8:00 AM to 12:00 NN and from 1:00 PM to 5:00 PM. It shall make a record from 5:00 AM to 12:00 NN and from 1:00 PM to 5:00 PM. It shall make a record hours from 8:00 AM to 12:00 NN and from 1:00 PM to 5:00 PM. It shall make a record time and date when an employee goes "out" and "in" during said hours and shall submit a Monthly Summary Report thereof to the Office of the College President;
- 11. The SECURITY AGENCY shall observe the highest degree of diligence in implementing security measures for CNSC and it shall be its duty to make intelligent observations to improve security measures, identify security lapses, foresee future security risks and make appropriate and timely recommendation to CNSC authorities as to how to immediately address these concerns. Moreover, a monthly Security Observation Report shall be submitted to the office of the College President;
- 12. The SECURITY AGENCY undertakes to provide additional reinforcement or augmentation of at least Five (5) Security guards during CNSC special occasions, augmentation of at least Five (5) Security guards during CNSC special occasions, such as Commencement Exercises, Foundation Day Celebration and the like, where crowd control and safety of persons inside CNSC premises is a priority;
- 13. By virtue of this contract, the SECURITY AGENCY assumes liability for all losses, damages, destruction to CNSC properties and for death and / or injuries sustained damages, destruction to CNSC properties and for death and / or injuries sustained damages, destruction to CNSC properties and for death and / or injuries sustained by its officers, employees, and visitors / guests, which are directly attributable to the by its officers, employees, and visitors / guests, which are directly attributable to the security guards;
- The CNSC shall, by written Notice of Suspension to the SECURITY AGENCY, suspend all payments if the latter fails to perform its obligations under this Contract Agreement;
- Any loss or damaged upon CNSC's premises, properties and personnel during the guarding duty of the SECURITY AGENCY's guards shall be indemnified by the SECURITY AGENCY, unless the loss or damage was due to fortuitous events or force majeure;
- 16. CNSC may terminate this Contract Agreement thru written Notice of Termination give to the SECURITY AGENCY Thirty (30) days after the concurrence of any of the following:
 - A. The SECURITY AGENCY fails to remedy its failure in the performance of its obligations to CNSC.
 - B. The SECURITY AGENCY becomes bankrupt.
 - C. The SECURITY AGENCY's representation materially affected the interest of CNSC.
 - D. The SECURITY AGENCY is unable to perform substantial and material portion of the security services as required by CNSC and as embodied in this contract.

- Upon termination of this contract and upon receipt of the notice of termination, the SECURITY AGENCY shall take all the necessary steps to bring their services to a close in a prompt and orderly manner,
- Unless sooner terminated, this CONTRACT shall be valid from OCTOBER 1, 2022. and shall terminate on SEPTEMBER 30, 2023; and
- 19. The SECURITY AGENCY shall furnish the CNSC such Performance Security in the form and amount as indicated in the General Conditions of the Contract.
