1. The **CAMARINES NORTE STATE COLLEGE**, through the **2021 GAA FUND** intends to apply the sum of **Fourteen Million Seven Hundred Ninety-Nine Thousand Nine Hundred Ninety-Four Pesos and 71/100 only (P14,799,994.71)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Completion of Centralized Power House (2MVA with Primary and Secondary Lines), Camarines Norte State College, Main Campus, Daet, Camarines Norte** with Project Reference Number: **COMCENTRPOWHV2-2021**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CAMARINES NORTE STATE COLLEGE** now invites bids for the above Procurement Project. Completion of the Works is required **ONE HUNDRED TWENTY (120) CALENDAR DAYS**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the Head, BAC Secretariat, Records Office, 2nd Floor, General Administration Building and inspect the Bidding Documents at the address below from 8:00 A.M. to 5:00 P.M. Monday to Friday

A complete set of Bidding Documents may be acquired by interested bidders on **November 15-28,2022** from given address upon payment of non-refundable fee pursuant to the latest Guidelines issued by the GPPB in the amount of **Twenty-Five Thousand (P25,000.00) Pesos**. CNSC shall allow the bidder to present its proof of payment for the fees by presenting the original copy of the official receipt or through electronic mail.
6. The **CAMARINES NORTE STATE COLLEGE** will hold a Pre-Bid Conference **November 21,2022** at the **2nd Floor, College Library at exactly 1:30 in the afternoon** which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission on **December 5, 2022 at exactly 2:00 o'clock in the afternoon** at the Office of the Head, BAC Secretariat, Records Office, 2nd Floor, General Administration Building, Main Campus Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **December 5,2022** at exactly 2:15 in the afternoon at the second floor **College Library Building**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
