The Camarines Norte State College – Bids and Awards Committee (BAC) through the 2024 REGULAR AGENCY FUND intends to apply the total of sum of One Million Five Hundred Forty Five Thousand Nine Hundred One Pesos (₱1,545,901.00) with Reference No. CNSCITEQUIPRAF2024. Bids received in excess of the ABC shall be automatically rejected.

- 1. The <u>Camarines Norte State College</u> now invites bids for the above Procurement Project. Delivery of the Services as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, <u>within five (5) years</u> from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- **4.** Prospective Bidders may obtain further information from Camarines Note State College and inspect the Bidding Documents at the address given below during office hours, Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>in payment of the applicable fee for the Bidding Documents</u>, pursuant to the latest <u>Guidelines issued by the GPBB in the amount of Five Thousand Pesos (P5,000.00)</u>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The CAMARINES NORTE STATE COLLEGE will hold a Pre-Bid Conference on April 29, 2024, at the Office of the Vice President for Administration and Finance, 2nd Floor, GASS Building, CNSC Main Campus, Daet, Camarines Norte at exactly 9:30 in the morning which shall be opened to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before May 13,2024 at 9:00 in the morning. Late bids shall not be accepted.
- **8.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on <u>May 13, 2024 at 9:30 in the morning</u> at the Office of the VP for Administration and Finance. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Camarines Norte State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
