NEGOTIATED PROCUREMENT DUE TO TWO FAILED BIDDING (Section 53.1)

Procurement of CNSC Vehicles for the Jose Panganiban and Mercedes Campus, Camarines Norte

1. In view of the two (2) failed biddings, the Camarines Norte State College – Bids and Awards Committee (BAC) through the **2023 INTERNALLY GENERATED FUND** as per Authority to Purchase Motor Vehicle (APMV) No. RO-23-005 intends to apply the total of sum of **Four Million Eight Hundred Thousand Pesos (P4,800,000.00)** for the **Procurement of CNSC Vehicles for the Jose Panganiban and Mercedes Campus**, with Reference No. **CNSCMOTORVEH2023**. Bids in excess of the ABC shall be automatically rejected.
2. The Camarines Norte State College now invites bids for the above Procurement Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within the period of five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. The CNSC BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, and which would meet the minimum technical specifications required.
