In consideration for the sum of Eight Hundred Thirty-Five Thousand Eight Hundred Eighty-Eight Pesos (PHP 835,888.00) or such other sums as may be ascertained, KITCHEN MALL (KMC) CORPORATION agrees to SUPPLY, DELIVERY AND INSTALLATION OF EQUIPMENT FOR QP NICER PROJECT 3 at CNGC Main Campus, Daet, Camarines Norte in accordance with his/her/its Bid.




4. The **CAMARINES NORTE STATE COLLEGE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

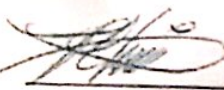

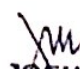
