RE-CERTIFICATION OF CNSC QUALITY MANAGEMENT SYSTEM (QMS)

1.0 BACKGROUND AND OBJECTIVES

The institutionalization of internationally recognized Quality Management System (QMS) thru Certification of all the campuses and process to ISO 9001:2015 Standard has paved the way to opportunities that will continually improve the delivery of our services in Instruction (Higher Education and Advanced Studies), Research, Extension and Production. In line with the management commitment to continually improve its operations and services, the Camarines Norte State College (CNSC) shall undergo its Recertification Audit this November 2021.

The objective of the above-said audit, aside from its purpose of determining compliance with the ISO Standard, is to maintain the College's good standing, thereby be compliant with the requirements of the existing DBM issuances on performance improvement of government agencies.

2.0 ESTIMATED COST/FEE

- 4.1.3 – Define the audit processes suitable for both parties (CNSC and Certification body)


4.5 CONFIDENTIALITY

The same applies to confidential information transmitted by email. If confidential information is disclosed orally, the receiving party shall be appropriately informed in advance. All confidential information which the disclosing party transmits or otherwise discloses to the receiving party in accordance with this agreement: a) may only be used by the receiving party for the purposes of performing the purpose of the contract, unless expressly otherwise agreed in writing with the disclosing party; b) may not be copied, distributed, published or otherwise disclosed by the receiving party, unless this is necessary for fulfilling the purpose of the contract or TÜV Rheinland Philippines, Inc. is required to pass on confidential information, inspection reports or documentation to the authorities or third parties that are involved in the performance of the contract.




