INVITATION TO BID FOR *Provision of Hotel Accommodation, Food and Conference Facilities for the CNSC In-House Planning and Budgeting (Early Procurement 2022)*

1. The Camarines Norte State College, through the 2022 General Appropriations Act intends to apply the sum of One Million Forty Thousand Pesos (P1,040,000.00) being the ABC to payments under the contract for Provision of Hotel Accommodation, Food and Conference Facilities for the CNSC In-House Planning and Budgeting (Early Procurement 2022). For the purpose of early procurement authorized under Section 7.6 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, the proposed budget under the FY 2022 National Expenditure Program shall be used as basis. Further, consistent with the requirement in the same section 7.6 **no award of contract shall be made until the approval and effectivity of the FY 2022 General Appropriations Act**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Camarines Norte State College now invites bids for the above Procurement Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Camarines Norte State College and inspect the Bidding Documents at the address given below during office hours, Monday to Friday.
