



Invitation to Bid for the Repair and Rehabilitation of Infrastructure Building in Mercedes Campus, Camarines Norte

The **CAMARINES NORTE STATE COLLEGE**, through the **2022 INCOME FUND** intends to apply the total amount of **Three Million Nine Hundred Ninety-Nine Thousand Nine Hundred Sixty-Three Pesos (P3,999,963.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **the Repair and Rehabilitation of Infrastructure Building in Mercedes Campus** with Reference No. **CNSCREPMERCM2022**.

1. The **CAMARINES NORTE STATE COLLEGE** now invites bids for the above Procurement Project. Completion of the Works is required **ONE HUNDRED THIRTY (130) CALENDAR DAYS for Approved Budget for the Contract in the amount of Three Million Nine Hundred Ninety-Nine Thousand Nine Hundred Sixty-Three Pesos (P3,999,963.00)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
3. Interested bidders may obtain further information from the Head, BAC Secretariat, Records Office, 2nd Floor, General Administration Building and inspect the Bidding Documents at the address below from 8:00 A.M. to 5:00 P.M. Monday to Friday
4. A complete set of Bidding Documents may be acquired by interested bidders on October 12-28, 2022 from given address upon payment of non-refundable fee pursuant to the latest Guidelines issued by the GPPB in the amount of five thousand pesos (P5,000.00). CNSC shall allow the bidder to present its proof of payment for the fees by presenting the original copy of the official receipt or through electronic mail.
5. The **CAMARINES NORTE STATE COLLEGE** will hold a Pre-Bid Conference November 22, 2022 at the **Second Floor, College Library at exactly 2:00 o'clock in the afternoon** which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission on **December 7, 2022 on or before 1:45 in the afternoon** at the 2nd Floor, General Administration Building, Main Campus, Daet, Camarines Norte. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
8. Bid opening shall be on **December 7, 2022** at exactly 2:15 in the afternoon at the first floor **College Library Building**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **CAMARINES NORTE STATE COLLEGE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
