The Camarines Norte State College – Bids and Awards Committee (BAC) through the 2025 *REGULAR AGENCY FUND* intends to apply the total of sum of **Seven Million Two Hundred Thousand Pesos (₱7,200,000.00)** with Reference No. CNSCPASVAN2025. Bids received in excess of the ABC shall be automatically rejected.

1. The *Camarines Norte State College* now invites bids for the above Procurement Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Camarines Note State College* and inspect the Bidding Documents at the address given below during *office hours, Monday to Friday*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on in payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB in the amount of Ten Thousand Pesos (P10,000.00). Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **CAMARINES NORTE STATE COLLEGE** will hold a Pre-Bid Conference on **October 17, 2024**, at the Office of the Vice President for Administration and Finance, 2nd Floor, GASS Building, CNSC Main Campus, Daet, Camarines Norte at exactly 2:00 o'clock in the afternoon which shall be opened to prospective bidders or thru this link: <https://meet.google.com/yzv-afia-rjr>.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before October 29, 2024 at 9:30 in the morning. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on October 29, 2024 10:00 o'clock in the morning at the Office of the VP for Administration and Finance. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity or thru this link: <https://meet.google.com/yzv-afia-rjr>.
