 The Camarines Norte State College through the Bids and Awards Committee (CNSC-BAC) intends to apply the sum of Six Hundred Fifty Thousand (P650,000.00) Pesos being the Approved Budget for the Contract (ABC) for the consultancy services for the design analysis, checking, signing and sealing of electrical plan for the Centralized Power House (2MVA) with primary and secondary lines).

Bids received in excess of the ABC shall automatically be rejected at the opening of the proposals.

- 2. The Camarines Norte State College now calls for the submission of eligibility documents for the consultancy services for the design analysis, checking, signing and sealing of electrical plan for the Centralized Power House (2MVA) with primary and secondary lines).
- Interested bidders may obtain further information from the Office of the Head, BAC Secretariat, Records Office, 2nd Floor General Administration Building and inspect the Bidding Documents at the address given below from 8:00 A.M.;

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- Pre-bid conference is optional, however, the BAC will hold a conference at the option of the bidder's attendance on February 18, 2020 at 2 o'clock in the afternoon at the College Board Room.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on February 13-21, 2020 from the address below upon payment of non-refundable fee of One Thousand Pesos (P1,000.00).
- 6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184, otherwise known as the "Government Procurement Reform Act", and its implementing Rules and Regulations (IRR).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the IRR of RA 9184 on February 24, 2020 at 9:30 in the morning upon declaration of the "passed" rating of all the technical documents, opening of the financial envelope will be opened the same day.
- The Procuring Entity shall evaluate bids using the Quality-Cost Based Evaluation (QCBE) procedures, to be given the following corresponding weights:


